

On grounds of the provisions of Article 3 letter b) indents 3 and 4, of Article 10(2) indents 4, 5, 8 and 10, of Article 11(1) and of Article 12(1) and (3) of the Government Emergency Ordinance no.22/2009 on the establishment of the National Authority for Management and Regulation in Communications, approved by Law no.113/2010, as well as of Article 11(1) and Article 21(1) of the Government Emergency Ordinance no.79/2002 on the general regulatory framework for communications, approved with amendments and completions by Law no.591/2002, with the subsequent amendments and completions,

issues this:

DECISION
on amending and completing certain regulations
in the numbering resources field

Art.I. – The decision of the president of the National Regulatory for Communications and Information Technology no.2895/2007 on the National Numbering Plan, published in the Romanian Official Journal, Part I, no.608 of 4 September 2007, shall be amended as follows:

1. Within Article 12, paragraph (3) shall be amended and shall read as follows:

“(3) The 19vx and 19vxy national short numbers are used for the provision of services of national public interest.”

2. Article 37 shall be repealed.

Art.II. – The decision of the president of the National Regulatory for Communications and Information Technology no.2896/2007 on the procedure of requesting and granting licences for the use of numbering resources, published in the Romanian Official Journal, Part I, no.609 of 4 September 2007, with the subsequent completions, shall be amended and completed as follows:

1. Within Article 1, paragraphs (2) and (3) shall be amended and shall read as follows:

“(2) The National Authority for Management and Regulation in Communications, hereinafter referred to as ANCOM, may grant the right to use certain numbering resources provided in the National Numbering Plan, hereinafter referred to as the PNN, to a provider of publicly available electronic communications services registered in Romania, according to the law.

(3) This decision shall not apply to the numbers with special economic value, set out by ANCOM, and granted through a competitive or comparative selection procedure.”

2. Within Article 3 paragraph (2), letter g) shall be amended and shall read as follows:

“g) 19vx or 19vxy short numbers for public interest services at national level;”.

3. Within Article 3 paragraph (2), after letter h) a new letter shall be introduced, letter i), reading as follows:

“i) other categories of numbering resources in the PNN, pursuant to certain special regulations.”

4. Within Article 5 paragraph (1), after letter a) a new letter shall be introduced, letter a¹), reading as follows:

“a¹) a copy of the registration certificate issued by the National Trade Register Office to the legal person or to the authorised natural person, to the family association, to the individual enterprise or family enterprise, as the case may be, or a copy of the fiscal registration certificate, as well as a copy of the certificate of registration with the Associations and Foundations Register or with the Federations Register, as the case

may be, as per the persons who are not undertakings, if such documents have not been sent to ANCOM within the general authorisation procedure;”.

5. Within Article 5 paragraph (1), letter d) shall be amended and shall read as follows:

“d) in view of allotting certain blocks of numbers for general interest services at local level within the 0Z = 02 and 0Z = 03 domains, the characteristics and detailed description of services to be provided by means of these numbers, specifying the categories of subscribers to whom these numbers shall be assigned, as well as the local availability of similar services; the requester shall transmit copies of the pre-contracts or agreements concluded for the provision of services within this category, for at least one of the numbers of each block of 10 numbers requested, as well as information regarding the capacity of the network which was allotted for the provision of such services;”.

6. Within Article 6 paragraph (8), letter b) shall be amended and shall read as follows:

“b) 80%, for the 6 digit geographic numbers in the 0Z = 02 and 0Z = 03 domains in the PNN;”.

7. Within Article 15 paragraph (2), letter f) shall be amended and shall read as follows:

“f) the documents under Article 5(1) letter a¹) for the assignee and the implementation specifications for each category of numbering resources transferred, according to Annex no.2 to this decision;”.

8. Within Article 15, paragraph (5) shall be amended and shall read as follows:

“(5) ANCOM shall analyse whether the assignee meets the conditions for the allocation of the numbering resources to be transferred, whether the destination of the numbers as provided in the PNN and the technical terms for routing the calls originated¹

from, and terminated to the transferred numbers, as the case may be, are observed, as well as whether by transferring the LURN, the competition is restricted, foreclosed or distorted.”

9. Within Article 15 paragraph (8), letter c) shall be amended and shall read as follows:

“c) following the transfer of the licence, the technical terms for routing the calls originated² from, and terminated to the transferred numbers, as the case may be, shall be changed, so that operational problems for other providers of electronic communications networks or services may occur;”.

10. Within Article 19 paragraph (1), after letter e) a new letter shall be introduced, letter a¹), reading as follows:

“f) the blocks of numbers or the carrier selection codes shall not be used for more than 9 months, except for the thoroughly justified cases which rendered impossible the use of the respective numbering resources.”

Art.III. – This decision shall be published in the Romanian Official Journal, Part I, and shall enter into force within 3 days from its publishing date.
