### DECISION

## on identifying the relevant markets in the electronic communications sector corresponding to the services of leased lines-terminating segments with the transmission capacity of up to and including 2 Mbps

**Art.1.** – This decision identifies the relevant markets in the electronic communications sector corresponding to the services of leased lines-terminating segments with the transmission capacity of up to and including 2 Mbps, provided in the Annex which is part thereof, whose characteristics may justify the imposition of certain specific obligations on the providers of electronic communications networks and services.

**Art.2.** – The National Authority for Management and Regulation in Communications undertakes, periodically, market analyses in the market identified pursuant to Article 1, with a view to determining the competitive environment and the necessity to impose, maintain,

amend or withdraw the specific obligations provided in the Second Chapter of the Government Ordinance no.34/2002 on the access to the public electronic communications networks and to the associated infrastructure, as well as on their interconnection, approved with amendments and completions, by Law no.527/2002, with the subsequent amendments and completions.

Art.3. – This decision shall be published in the Romanian Official Journal, Part One.

#### **ANNEX**

### THE RELEVANT MARKETS IN THE ELECTRONIC COMMUNICATIONS SECTOR CORRESPONDING TO THE SERVICES OF LEASED LINES-TERMINATING SEGMENTS WITH THE TRANSMISSION CAPACITY OF UP TO AND INCLUDING 2 MBPS

#### a) Product relevant market

The market for the services of leased lines-terminating segments with the transmission capacity of up to and including 2 Mbps.

The market consists of the services offering the segment of leased line-total circuit delineated by an interconnection point for leased lines, located at the level of the regional transmission network, of the subordinated local transmission network or of the subordinated access network, in line with the network architecture, and a network terminal point located within the same county with the interconnection point, with the transmission capacity of up to and including 2 Mbps, irrespective of the technologies or protocols or interfaces used.

The identified market is a wholesale market, on which *ex ante* obligations may be imposed in accordance with the provisions of the Government Ordinance no.34/2002 on the access to the public electronic communications networks and to the associated infrastructure, as well as on their interconnection, approved with amendments and completions, by Law no.527/2002, with the subsequent amendments and completions.

#### b) Relevant geographic market

The national market determined by Romania's territory.
