NON-BINDING ENGLISH TRANSLATION

On grounds of the prime minister decision no. 249/2005 on the designation of the president of the National Regulatory Authority for Communications,

On grounds of the provisions of art.38 (1), (3) and (5), art.34(3), as well as under art.46(1), p.11 of Government Emergency Ordinance no.79/2002 on the general regulatory framework for communications, approved, with revisions and amendments, by Law no.591/2002, as well as of art.8 (1) and art.13 of the Government Ordinance no.34/2002 on the access to the electronic communication networks and to the associated infrastructure, as well as their interconnection, approved, with revisions and amendments, by Law no.527/2002,

Considering the provisions under art.1 (7) of the ANRC President's Decision no.147/EI/2002 on the principles and prerequisites of the reference offer for interconnection with the public fixed telephony network, with subsequent revisions and amendments,

Considering the provisions of the regulation for the realization of the top-down long run incremental costing model by "ROMTELECOM" S.A., approved through ANRC's President Decision no. 1381/2003,

Considering the results of the reconciliation process between the top-down long run incremental costing model developed by "ROMTELECOM" S.A. and the bottom-up long run incremental costing model developed by ANRC,

THE PRESIDENT OF THE NATIONAL REGULATORY AUTHORITY FOR COMMUNICATIONS

Issues the present:

DECISION

- Art.1. (1) Maximum tariffs which can be charged by "ROMTELECOM" S.A. for the interconnection services stipulated under art. 3 of ANRC's President Decision no. 147/2002 on the principles and prerequisites of the reference offer for interconnection with the public fixed telephony network, with subsequent revisions and amendments, together with the dates at which they shall entry into force, are stipulated under the annex which forms an integral part of the present decision.
- (2) In case of calls originated from public payphones, interconnection tariffs can exceed the ones stipulated under point (1) above, in the limit given by the ratio between retail tariffs for calls originated from public payphones and retails tariffs for calls originated from individual subscriber lines.
- Art. 2 (1) Within 10 days from acknowledgement of the present decision, "ROMTELECOM" S.A. has the obligation to submit to ANRC in electronic version and on hard

paper, and to publish on its web page, a reference interconnection offer with the public fixed telephony network it operates, revised according to the provisions of the present decision.

- (2) Within 10 days from acknowledgement of the present decision, "ROMTELECOM" S.A. has the obligation to publish on its web page, the standard interconnection contract specimen, revised according to the provisions of the present decision.
- (3) In case of existing interconnection agreements, concluded before acknowledgement of the present decision, "ROMTELECOM" S.A. has the obligation to make all efforts necessary, according to contractual provisions, to modify these agreements in compliance with the provisions of the present decision, so that tariffs stipulated in the annex shall be effectively applied from 1^{st} of January 2006 and 1^{st} of January 2007, respectively.
- Art. 3 Points (1) and (1^1) of article 32, and Annex 4 from ANRC's President Decision no. 147/2002, shall be abrogated from 1^{st} of January 2006.
 - Art.4. The present decision is communicated to "Romtelecom" S.A.
