

On grounds of the provisions of Art.38 paragraphs (1), (3) and (5), as well as of Art.46 paragraph (1) subparagraph 7 of the Government Emergency Ordinance no.79/2002 on the general regulatory framework for communications, approved with amendments and completions by Law no.591/2002,

issues the present:

**DECISION
regarding measures for the efficient use of the numbering resources**

Art.1. – This decision establishes certain measures for the efficient use of the numbering resources regarding the provision of various services, stipulated in the National Numbering Plan adopted by the Decision of the President of the National Regulatory Authority for Communications no.140/EN/2002, published in the Official Gazette of Romania, Part I, no.20 of January 15, 2003, amended by the Decision of the President of the National Regulatory Authority for Communications no.137/EN/2004, published in the Official Gazette of Romania, Part I, no.479 of May 28, 2004, hereinafter referred to as *NNP*, in the domain OZ = 08, as well as for the efficient use of the individual 10xyz indicatives for carrier selection.

Art.2. – After 7 months from the entry into force of this decision, the providers of publicly available electronic communication services shall be forbidden to use - with a view to providing services by means of virtual or prepay cards – other numbering resources than those provided in the NNP in the domains OZAB = 0801, OZAB = 0807 and OZAB = 0808 or 10xyz individual indicatives for carrier selection.

Art.3. – After 3 months from the entry into force of this decision, the providers of publicly available electronic communication services shall stop selling virtual and prepay cards with a view to providing the services stipulated in Art.2 by using other numbering resources than those provided in the NNP, in the domains OZAB = 0801, OZAB = 0807 and OZAB = 0808 or 10xyz individual indicatives for carrier selection.

Art.4. – By the end of a period of two months from the entry into force of this decision, the providers of publicly available electronic communication services that offer such services as provided in Art.2 by using other numbering resources than those provided in the NNP in the domains OZAB = 0801, OZAB = 0807 and OZAB = 0808 or 10xyz individual indicatives for carrier selection shall make available for the end users clear information regarding the changes in the numbering resources to be used for the provision of the respective services, including

the deadline for the use of the current numbering resources, by means of publishing the respective information on their Internet page and by posting it in visible places, at all the commercial offices of the providers or of their agents.

Art.5. – This Decision shall be published in the Official Gazette of Romania, Part I, and shall enter into force within 3 days from the publishing date.
