On grounds of the provisions of Article 6(1) indent 7 and of Article 7(1), (3) and (5) of the Government Emergency Ordinance no.134/2006 on the establishment of the National Regulatory Authority for Communications and Information Technology, as well as of Article 28 of Law no.304/2003 on the universal service and users' rights relating to the electronic communications networks and services, with the subsequent amendments and completions,

THE PRESIDENT OF THE NATIONAL REGULATORY AUTHORITY FOR COMMUNICATIONS AND INFORMATION TECHNOLOGY issues the present:

DECISION

on the amendment and completion of the Decision of the President of the National Regulatory Authority for Communications no.144/EN/2006 on the implementation of number portability

- **Art.I.** The Decision of the President of the National Regulatory Authority for Communications no.144/EN/2006 on the implementation of number portability, published in the Romanian Official Journal, Part I, no.352 of April 19, 2006, shall be amended and completed as follows:
- 1. Within Article 4 paragraph (1), after letter a) a new letter shall be introduced, letter a¹), reading as follows:
 - "a 1) location independent numbers within the 0Z = 03 domain;".
- 2. Within Article 4 paragraph (1), letter c) shall be amended and shall read as follows:
- "c) non-geographic national numbers for various services, in the following subdomains of the 0Z = 08 domains:
 - 1. OZAB = 0800 freephone numbers;
 - 2. 0ZAB = 0801 numbers for shared cost services/ universal access numbers;

- 3. OZAB = 0802 -personal numbers;
- 4. 0ZAB = 0803 numbers for shared cost services/universal access numbers;".

3. Within Article 9, paragraph (2) shall be amended and shall read as follows:

"(2) The porting request shall be revoked no later than 24 hours before the moment agreed for achieving the porting. If this term is exceeded, the porting of the number shall be completed, following that, upon the subscriber's request, a new porting process shall be initiated."

4. Within Article 19 paragraph (2), letter a) shall be amended and shall read as follows:

"a) 13 Euros for each ported number, for the portability of geographic numbers and location independent numbers and for the portability of non-geographic numbers, other than the ones intended for mobile telephone services;".

5. Within Article 21, paragraph (1) shall be amended and shall read as follows:

"Art.21. – (1) The providers of publicly available telephone services have the obligation to make available for the end-users, cost-free, upon their request, detailed, clear and updated information on the number portability service, including on the tariffs charged for the provision of this service and for the calls initiated to the ported numbers, both in writing, and by calling a Customer Relations Services, under the conditions established by ANRCTI."

Art.II. – The present decision shall be published in the Romanian Official Journal, Part I, and shall entry into force within 3 days from its publication.
