issues this:

DECISION

on the maximum tariffs that may be charged for access on, over, in or under public property real estate

Art. 1. - (1) The entities under Art. 6(1) and (2) of Law no. 159/2016 on the regime of electronic communications networks infrastructure and on establishing certain measures for reducing the cost of electronic communications networks roll-out may charge the electronic communications network providers the maximum tariffs provided in the Annex, for exercising the right of access on, over, in or under public property real estate.

(2) For the elements of electronic communications networks and physical infrastructure elements not included in the Annex, respectively antennas, cabinets, technical rooms, drawing rooms, ducts, base stations, poles, pillars, towers, other associated equipment and physical infrastructure, as well as for the cables and boxes for which one exercises other type of access than provided in the Annex, the tariff for exercising the right of access on, over, in or under public property real estate cannot

exceed the value of zero lei.

(3) The Annex is part of this decision.

Art. 2. – This decision shall be published in the Romanian Official Journal, Part I.
