The President of the National Authority for Management and Regulation in Communications of Romania issued the present decision.

Art. I

Decision of the President of the National Authority for Management and Regulation in Communications of Romania no. <u>311/2016</u> on license exempt radio frequencies or radio frequency bands, published in the Official Journal of Romania, Part I, no. 228 of March 28, 2016, is amended as follows:

1. Article 1, letter a) is amended and shall have the following content:

"a) designation of radio frequencies or radio frequency bands for the use of which is not required to obtain a license for radio frequencies usage, for certain categories of radio equipment;"

2. Article 3 is amended and shall have the following content:

"Article 3

Categories of radio equipment using license exempt radio frequencies or radio frequency bands are listed in the Annex which is an integral part of this Decision."

3. Article 4 is amended and shall have the following content:

"Article 4

The technical specifications for the RO-IR radio interfaces contain the requirements for putting into function and using the radio equipment for reasons related to compliance with the essential requirement referred to in Article 3 paragraph (2) of the Government Decision no. <u>740/2016</u> on making available on the market of radio equipment."

4. Article 5 is amended and shall have the following content:

"Article 5

The technical specifications for RO-IR radio interfaces regulated by this Decision shall be periodically updated, where appropriate, on the ground of relevant European or international regulations and published on the National Authority for Management and Regulation in Communications of Romania website."

5. In the annex, the table head changes and will have the following content:
