

## Termination at a fixed location

The maximum tariffs that the Operators designated as having significant power can charge for the provision of services of fixed call termination to geographic numbers, to location-independent numbers and to national short numbers for services of national public interest, except for those used for the enquiry services, on each public telephone network, irrespective of the technology or transmission environment used or by the national or international origin of the calls, inclusive of calls provided through the provider's own network or through a third party's network, via the managed VoIP technology, for which the quality of service is controlled by the service provider upon creating, on the access network, a separate, physical or virtual, permanent channel, dedicated to the IP voice traffic or upon prioritizing voice packages, will not exceed:
